### PROGRAM ELIGIBILITY:

Lawn & Landscape Professionals, Amenity Turf Managers and Sod Growers who purchase a minimum of \$5,000 worth of Qualifying Products during the Early Order Period (October 1, 2018 through February 28, 2019) ("Program Participants") qualify for the GreenTrust® 365 Lawn & Landscape Program. Qualifying Products are all products listed on the 2019 GreenTrust 365 Lawn & Landscape Program Worksheet, when purchased from a Syngenta Authorized Distributor/Agent/Retailer.

### PROGRAM DETAILS:

#### GreenTrust 365 Rebate

#### Barricade Brand Bonus Rebate

If a Program Participant meets the minimum \$5,000 purchase requirement described above, then they will also be eligible to earn a Barricade Brand Bonus Rebate.
